



1. Introduction

This Privacy Policy governs how Ibisly, LLC ('we', 'our', 'us') collects, uses, shares, and protects information obtained through our website, www.ibisly.com and www.ibissuite.com (the 'Website'). By using our Website or services, you agree to the terms of this Privacy Policy.

2. Definitions

"Non-Personal Information" (NPI) means information that is not personally identifiable and is obtained automatically when you access our Website with a web browser.

"Personally Identifiable Information" (PII) means non-public information that is personally identifiable to you and is obtained so that we may provide products or services. Examples include your name, address, phone number, credit card information, or other identifying details.

3. Our Commitment to Your Privacy

4. Information We Collect

We collect information directly from you when you provide it voluntarily, and automatically through your browser or device.

5. How We Use Information

We use your personal information to operate and improve our Website, respond to your inquiries, provide services, process payments, and send transactional or promotional communications.

6. Data Retention and Deletion

We retain personal information only as long as necessary to fulfill the purposes described in this Policy, comply with legal obligations, resolve disputes, and enforce agreements. When data is no longer needed, we take reasonable steps to securely delete or de-identify it.

7. Sharing Information with Affiliates and Third Parties

We do not sell your personal information. We may share information with affiliates and service providers who perform functions on our behalf, such as payment processing, hosting, analytics, or customer support. These parties are contractually bound to use information solely for the services they provide to us.

8. California Consumer Privacy Act (CCPA) Rights

Under the California Consumer Privacy Act (CCPA) and the California Privacy Rights Act (CPRA), California residents have specific rights regarding their personal information. These include the right to:



- Know what personal information we collect, use, disclose, or sell;
- Request deletion of your personal information;
- Opt out of the sale or sharing of personal information;
- Correct inaccurate information; and
- Not be discriminated against for exercising these rights.

We use encryption, secure servers, and access controls to protect personal information. While we employ industry-standard measures, no online transmission is entirely secure.

In the event of a data breach involving personal information, we will notify affected individuals in accordance with applicable U.S. state data breach notification laws, including the California Data Breach Notification Law (Cal. Civ. Code §§ 1798.29, 1798.82).

Our Website uses cookies and analytics technologies to personalize content, analyze site traffic, and improve performance.

We do not respond to browser 'Do Not Track' signals. However, you can adjust cookie preferences or opt out of analytics tracking using browser settings or tools such as the Google Analytics Opt-out Browser Add-on.

We do not knowingly collect personal information from anyone under the age of 18. If we become aware that we have collected such information, we will promptly delete it.
